Requisite fees are to be given to the concerned person during the consular camp in Mbabane (**for Swaziland**) or deposited in Cash into the bank account of the High Commission of India, Maputo.

The details of the bank account will be provided at the time of depositing the documents with the High Commission, or it can also be paid at the counter of the High Commission by debit card only, for which 1.01% extra will be charged by the bank.
